## **Course Information**

#### **Course Outcomes**

After successfully completing this course, students will be able to:

- Play entry-level, one- and two-handed pieces from written musical notation, demonstrating proper technique.
- Identify selected key signatures and play their major scales on the keyboard.
- Identify selected time signatures and note values and play melodies with rhythmic accuracy.

#### **How Outcomes Will Be Met**

The learning objectives of the course will be met through hands-on, in-class practice; lecture; at-home practice and study; and coaching by the instructor.

### **Grading & Assignments**

Exams will include objective tests of musical note and symbol recognition, as well as keyboard familiarity, and a series of piano performance "quizzes" in which each student demonstrates his or her progress by playing selected pieces individually for the instructor. In addition, perceived effort (record of attendance and evidence of time spent practicing, as shown through individual progress), will count for approximately half of the final grade.

#### **Books and Materials Required**

Required text: *Progressive Class Piano* (2<sup>nd</sup> ed.), by Elmer Heerema (Alfred Publishing)

Headphones or earbuds for the electronic keyboards

Appropriate plug adaptor (usually 1/8" to 1/4") if your headphones or earbuds don't already have a 1/4" jack.
