


### How do I apply for a Parent **Plus** Loan?

- 1) Apply for financial aid by completing the FAFSA, reading the Financial Aid Contract and filling out the BC Financial Aid Application at <http://bellevuecollege.edu/fa/apply/>.
- 2) Complete the Master Promissory Note (MPN) specifically for a Parent Plus Loan at <https://.studentloans.gov>.
- 3) Complete the Loan Application on the back of this form and return to BC's Financial Aid Office along with a  of your completed MPN.

### How Is My Tuition Paid?

Due to federal regulations the earliest your loan funds can disburse is three days before the quarter starts. Remember to maintain loan eligibility you must register for at least six credits applicable towards your program of study.

### What Happens if I Register Late?

If you only receive a loan and register late (have not registered 7 days before classes begin) your student loan is cancelled and funds **will** not be disbursed. We recommend you register as early as possible and to finalize your schedule 7 days before the quarter starts.

### What If I Drop Below 6 Credits Before the Census Date Occurs?

In order to keep eligibility for loans, students must maintain enrollment at 6 credits. If at any point your enrollment drops below 6 credits, before or after the 5th day of the quarter (census date), you risk losing your loan and/or grant eligibility.
