A regular meeting of the Board of Trustees of Community College District VIII, state of Washington, was held June 16, 2010 in room B201, Bellevue College, 3000 Landerholm Circle SE, Bellevue, Washington. Mr. Steve Miller, Chair, presided.

I. <u>EXECUTIVE SESSION</u>

Lucinda Taylor announced that there would be an executive session for approximately 120 minutes to discuss the selection of a site or the purchase of real estate when publicity regarding such consideration would cause a likelihood of increased price and to discuss evaluation of a state employee. Rachel Solemsaas and Cheryl Bateman were invited to join the board. The executive session began at 11:17 a.m. At 12:15 p.m., the board took a short break. The executive session resumed at 1:22 p.m. and Lucinda Taylor announced that the Bellevue College Board of Trustees would continue in executive session for approximately 60 minutes to discuss the evaluation of a state employee. At 2:24 p.m., Lucinda Taylor announced that the board would continue in executive session for approximately 20 minutes. At 2:45 p.m. Lucinda Taylor announced that the executive session would be extended by 2 minutes. The executive session ended at 2:49 p.m.

II. STUDY SESSION – Tab 1

Rachel Solemsaas, Vice President of Administrative Services, presented an overview of the 2010-11 college budget. Key points included:

- The college has experienced budget reductions of \$2,255,664 in the college's state funded allocation;
- Tuition increases of 7 percent for lower-division classes and 14 percent for baccalaureate level classes have been approved by the state and SBCTC and these increases are included in the proposed budget;
- Bellevue College was awarded \$903,756 in additional one time funding for worker retraining;
- We anticipate further reductions next biennium;
- Funding for our new Health Sciences Building has been delayed; and
- Steve Miller made note of the enormous time and effort that goes into preparing the budget and thanked Rachel Solemsaas, Mary Canan, Kelly Paustain and the Finance Office staff for their considerable effort.

<u>Topic</u>

Financial Report for Period Ending June 30, 2010

Description

The college provides periodic written reports to the Board of Trustees that identify budget changes or significant financial conditions for the board's discussion and action when necessary. The following report provides the college's financial status for the fiscal period July 1, 2009 to June 30, 2010. It includes budget adjustments made throughout the year for a variety of reasons, such as state allocation changes, changes in revenue based upon actual collection, new sources or changes in revenue sources, and/or adjustments in expenditures to align with collected revenue. This quarterly report documents all changes and provides a comparison of budgeted to actual revenue and expenditures to date. It should be noted that although some of the college's smaller funds for agency pass-through funds and endowment funds are not budgeted, their revenue and expenditures have been included in the attached report to provide a complete listing of the college's financial activities.

The purposes of the review is to analyze revenue and expenditure patterns against expectations, to identify emerging trends to see if they will have any bearing on future budgets, and to provide a record of adjustments and changes that differ from the budget plan. A summary of the budget revisions to date is identified immediately after the analysis.

Key Questions

- * What is the status of the college's financial activities for each fund?
- * What are revisions or changes in the college's budgets and why did they occur?

<u>Analysis</u>

The following summarizes the financial status of the College's funds as of June 30, 2010:

- <u>State and Local operating funds</u>: Revenue includes the state allocation, tuition and other miscellaneous operating income; in addition, one-time funding is budgeted as opening entries. Enrollments, and hence revenues, exceeded targets for the fiscal year while expenditures for these funds were less than budgeted. Excess revenues and fund balance allocated and not used are transferred to fund balance in support of reserves, local capital projects and contingencies.
- <u>Dedicated Local funds</u>: These funds include self-support programs, such as continuing education, computer lab fees, and lab and course fee accounts. These programs exceeded revenue collections for the year while posting lower expenditures than assumed in the approved budget.
- <u>Grants and Contracts</u>: Expenditures are consistent with revenues and in accordance with planned budget assumptions.
- <u>Proprietary funds</u>: These funds include ancillary and enterprise funds. In this category, revenue exceeded expenditures except for Stores and Motor Pool funds which are reflecting a timing difference between collections of reimbursement from other college funds and expenses it incurred.
- <u>Fiduciary funds</u>: This account contains assets held in trust for the state or account for assets which are held for eventual disbursement to authorized recipients, including individuals or private organizations. In addition, the 3.5% Financial Aid Fund has surpassed budgeted expenditures due to a required match for a Food Stamp Employment and Training grant and increased demand for aid.
- <u>Capital projects:</u> Capital funds are budgeted on a biennial basis. All revenue and expenditure activity follows the capital plan.

The following summarizes the budget revisions made for each fund:

Total Enrollment, Spring Quarter 2010 and Annual Enrollment Comparison Report

Description

The college continuously monitors and analyzes enrollment statistics and trends, particularly during registration and enrollment periods. Enrollment updates are regularly provided to the entire college during that time. Downward and upward trends are analyzed, and strategies are put into place to address areas of concern.

As part of the strategic enrollment and planning process, each quarter, an enrollment report for all fund sources (state-funded, self-support and other) is compiled for review and discussion. In addition to the Spring Quarter Final Enrollment report, an annual report is produced that provides an overall enrollment summary for this year as compared to last year.

Key Questions

- * Was the college's enrollment target for state funded and self-support FTES met for Spring Quarter 2010, and how did that performance compare to Spring Quarter 2009?
- * Were there any areas of enrollment that experienced significant differences (increase or decrease) for Spring Quarter 2010, and what are the reasons for those changes?
- * How do the final figures for enrollment for academic year 2009-10 compare to the enrollment figures for academic year 2008-09?

<u>Analysis</u>

The downturn in the state economy continues to persist and the state job outlook has shown little improvement. As a result, colleges statewide have been experiencing record enrollment numbers. These circumstances continue to be reflected in the Spring quarter and annual total enrollment data. The Governor's latest budget update predicting further reductions across the board will continue to stretch the resources we have to serve student needs, especially during periods of record enrollment.

Increase (or decrease) by division or unit:

- Our Spring 2010 enrollment target was exceeded by 961.1 FTES or 10.2%
- Arts and Humanities Division exceeded its target by 300 FTES or 9.5%
- Business Division exceeded its target by 107 FTES or 7.7%
- Health Science Division exceeded its target by 51.3 FTES or 6.1%
- Science Division exceeded its target by 331.2 FTES or 13.9%
- Social Science Division exceeded its target by 177.6 FTES or 11.6%
- Other Programs exceeded their target by .2 FTES or 0%

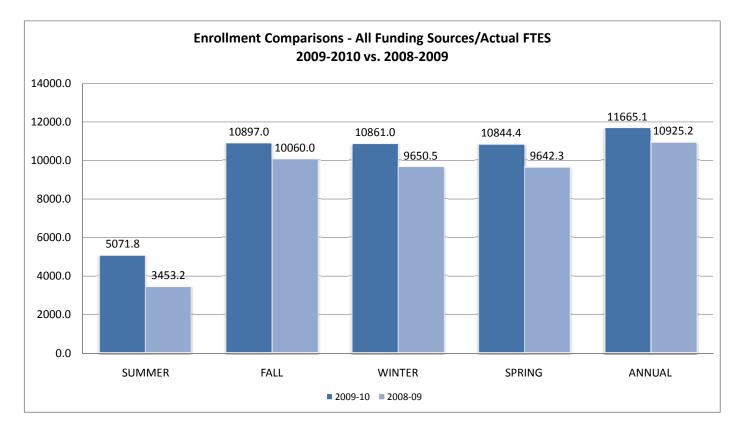

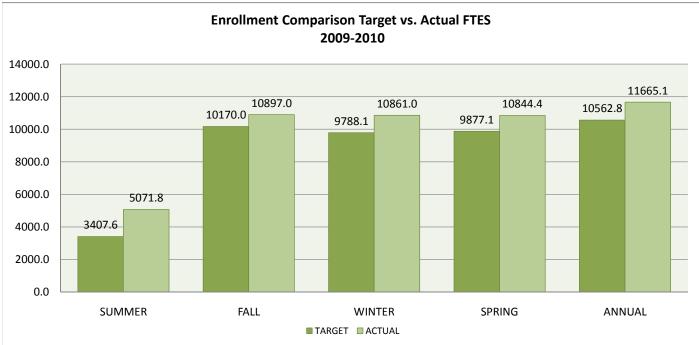

Representatives for the BC Association of Higher Education and Community College District VIII reached a tentative agreement on a successor agreement to replace the 2007-10 Negotiated Agreement. The faculty are scheduled to vote on the tentative agreement on September 15, 2010.

Key Questions

* Does the tentative agreement reached by representatives for the BCAHE and the Board of Trustees represent the mutual interests of the college and the faculty, and should the tentative agreement be approved?

Analysis

The college bargaining team believes the Tentative Agreement represents the mutual interests of the college and the association.

Background Information

Attachment 1 contains a summary of the substantive differences between the expired 2007-2010 Negotiated Agreement and the proposed 2010-2011 Negotiated Agreement tentatively agreed to by the parties.

Recommendation/Outcomes

The college bargaining team recommends that the Board of Trustees of Community College District VIII approve the proposed 2010-2011Negotiated Agreement between the Board of Trustees of Community College District VIII and Bellevue Community College Association of Higher Education as presented in the 2010-11 Faculty Contract Tentative Agreement, pending ratification by the faculty.

Proposed Changes to the Negotiated Agreement between the Board of Trustees of Community College District VIII and the Bellevue College Association of Higher Education

Representatives of the College and the BCAHE have reached a tentative agreement on a proposed Negotiated Agreement to be effective September 1, 2010 through August 31, 2011. Highlights of the changes are:

- 1. **Compensation**. Following legislative action allowing the use of salary turnover dollars to fund faculty increments, the parties reached agreement on the distribution of \$123,640 to fund increases for the 154 full-time faculty continuing from 2009-10 to 2010-11.
- 2. **Program Management Changes**. Following the dissolution of the Business Division and the creation of the Institute for Business and Information Technology (IBIT) effective July 1, 2010, and other organizational changes in Instruction, the parties redistributed existing program management funding among the instructional divisions.
- 3. Part-Time Faculty Performance Review Process. Based on recommendations from program chairs, the parties changed the timeline for the initial review to the second quarter of employment and emphasized the importance of mentoring and informal feedback to part-timers during the first quarter of employment.
- 4. Housekeeping. Dates in the agreement have been changed as needed. Names have been updated (BCC to BC, BCCAHE to BCAHE, and Executive Dean to Vice President, organizational units,) as needed. A number of the appendices and memoranda of understanding relating to pilot projects, name changes, etc. resulted in the deletion and renumbering of appendices and memoranda.

The parties engaged in discussion of a number of other issues (2011-12 calendar, workload items, Summer Quarter start date) but did not reach agreement during the time scheduled for negotiations.

The faculty expressed concern about the lack of input from faculty in the performance review of administrators. While there was no agreement to address this concern in the Negotiated Agreement, the administration committed to including faculty input in the performance review of administrators who had extensive interaction with faculty.

The parties agreed that bargaining for a successor agreement could begin after October 15, 2010. Both parties are interested in completing negotiations for a successor agreement before the end of the 2010-11 academic year.

Key Questions

- * Do the proposed dates meet the needs of the college in maintaining its administrative and contractual obligations?
- * Do the proposed dates conflict with any major religious or secular holidays or other dates that might cause key personnel to be unavailable?
- * Do the proposed dates meet the needs of the individual trustees?

<u>Analysis</u>

The proposed dates meet the needs of the college in maintaining its administrative and contractual obligations and do not conflict with any major religious or secular holidays. The Bellevue School District (BSD) calendar has also been taken into consideration and none of the proposed dates conflict with BSD breaks.

Background Information

The first meeting of the year should be scheduled as late as possible in January or early February to allow the Tenure Review Committee (TRC) as much time as possible to complete their recommendations. The BC Foundation Board of Directors (BCF) meets January 12, 2011. February 2, 2011 is the Christian observance of Candlemas.

State law requires that a tenure decision be made before the start of the candidate's 9th consecutive quarter (not counting summer) and the timing is such that we need to schedule a meeting in March. In addition, the BCCAHE negotiated contract requires that, if the Board disagrees with the recommendations of the TRC, this disagreement must be determined in open session and that the Board must then meet with the TRC at least five days before they make their final decision. In order to allow for this possibility and to avoid meeting during finals week, the March meeting should occur prior to March 11, 2011. Finals are scheduled for March 21-23, 2011 and the BCF is scheduled to meet on March 23, 2011. March 9, 2011 is the Christian observance of Ash Wednesday.

The Margin of Excellence Awards ceremony is scheduled for May 25, 2011 and we ask that the Trustees attend the ceremony as a study session. The BCF is scheduled to meet on May 11, 2011.

The budget needs to be approved in June and we typically schedule a second, tentative meeting to accommodate a late decision by the legislature. Our year-end event is scheduled for June 8, 2011 and the BCF is scheduled to meet on June 22, 2011.

The September meeting should be scheduled for the first or second Wednesday of the month to allow any negotiated changes in faculty salary to be implemented by the September 25 paycheck. This is assuming that we have reached tentative agreement and that there is a salary change to implement.

The October meeting is typically the first meeting for any newly appointed trustee and is an ideal time for a retreat to review the college's strategic planning for the coming year. Other considerations for October include the Hindu observance of Navaratri September 28 – October 5, 2011, the Jewish observance of Sukkot October 13-19, and the Jain, Hindu and Sikh observance of Diwali on October 26, 2011.

Recommendation/Outcomes

The proposed schedule of regular meeting dates for 2011 will be presented for approval at the November 17, 2010 meeting.
