Our Mission Statement

The mission of Bellevue College Running Start Program is to empower the intersection of identities of underage and high school students by offering educational opportunities, challenges, and resources which guide students to take control of their academic entry, progress, and completion.

Additionally, in tandem with <u>Achieving the Dream</u> the Running Start Program encourages and provides resources for students to take advantage of their dual credit opportunity and guide them along the path to complete their career and educational goals.

What is Running Start

Running Start is a dual credit program intended to provide students an option consisting of attendance at certain institutions of higher education and the simultaneous earning of high school and college/university credit. Running Start was initiated by the Legislature as a component of the 1990 parent and student <u>Learning by Choice Law.</u> Students in grades 11 and 12 are allowed to take college courses at any of the Washington community and technical colleges.

Running Start Students and their families do not pay tuition for the approved number of college credits they are awarded from their high school, but they do pay college fees and buy their own books, as well as provide their own transportation. Students receive both high school and college credit for these classes and therefore accelerate their progress through the education system. The exercise of that right is subject only to minimal eligibility and procedural requirements, which are spelled out, in state administrative rules. See <u>RCW 28A.600.300</u> for more information.

By doing Running Start all students...

- Boost their college applications by taking college level courses as a high school student.
- Learn how to navigate a college campus early so that if you attend a 4-year school later you are more comfortable with and prepared for college systems and expectations.
- Able to work on prerequisites for the major you wish to pursue in the future. And/or students can earn an Associate's Degree and complete your general education requirements of a Bachelor's degree.
- Become part of a new community!

Cost of Running Start

By participating in Running Start students can save a lot of time and money towards their college education! However, this is not a completely free program.

Tuition coverage:

A students' school district only covers tuition for the number of credits approved by their High School counselor.

Tuition is charged when a student enrolls in:

More credits than what they are approved for by their High School counselor. A below 100 level course (for example: Math 098). If you enroll in a below 100 level course, the tuition will be charged to your account within 1-2 business days after enrolling in the course.

Charges for Class and Student Fees:

Class and student fees are <u>not</u> covered, and students are responsible to pay these fees in order to stay registered in their courses. Class fees can be found on the course catalog below a course title.

Running Start is for students who...

- Can manage their time well, meet assignment deadlines and not expect extensions, late assignments, or extra credit options.
- Are ready for college level courses and a much faster pace. One quarter is about 11 weeks long which means an entire course that could take a year to cover in HS will be done in 11 weeks!
- Take initiative and advocate for themselves by communicating with their instructors, seeking out resources on campus, without their parents doing it for them.

Running Start can also be harmful to a student if... they are not ready

- If the student is not able to be successful in their classes and they earn low grades or fail classes, this can have a negative effect on the students college admissions prospects and the ability to earn financial aid in the future.
- The grades earned at BC are **permanent** part of their college transcript, and if the student continues to fail or withdraw from courses this can greatly impact their future college endeavors.

Running Start students are Bellevue College Students. They are held to the same expectations and policies as all other Bellevue College Students.

Students can do Running Start in a variety of ways:

- Student can attend BC **part-time** and explore academic areas of study, participate in music groups or drama productions, or work on their HS graduation requirements by taking a few classes at BC.
- Students can attend BC full-time and pursue an Associate's degree to get them ahead in their Bachelor's degree, work on general education requirements for a 4-year school, or work on prerequisites for a specific major.

Courses at BC

BC offers courses in a large variety of topics!

Courses in 8 world languages, Jazz Band, Theater, Engineering, Allied Health programming, Criminal justice, Computer Science, and more!

- Students can enroll in any courses offered at BC if they meet the placement and prerequisites.
- We offer classes on campus, hybrid (half on campus half online), and online!
- As a BC student you have a more flexible schedule. To be more specific: in HS you are in classes all day for up to 6 hours straight – at BC you might have only a few hours of class a few days per week.
- 1 High School Credit = 5 Bellevue College Credits.

Types of Courses

Bellevue College offers three types of courses: **in-person**, **online**, and **hybrid** (a combination of in-person and online). You can see what type of course by looking at the "Section" column under a course when looking at classes in the online course catalog. In-person classes are marked with an "A, B, C, or so on", online classes are marked with "OAS, OBS, OCS...", and hybrid courses are marked with "HYA, HYB, HYC..."

For **online classes there are two ways it can be run:** Synchronous or Asynchronous:

- Synchronous: The class has specific days and times that it will meet online. The instructor still uses Canvas for materials, but you are expected to attend class at those days and times listed on your schedule. You still will need to follow all guidelines provided by instructors in the syllabus for the course.
- Asynchronous: Any course that says "Online" or "Arranged" with no dates or times is an asynchronous course. The class will not meet at a specific day or time. The instructor will post materials to Canvas, and it is your responsibility to follow their guidelines in the syllabus for the course.

The Family Educational Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a **Federal law that protects the privacy of student education records**. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.

FERPA gives parents certain rights with respect to their children's education records. **These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level.** Students to whom the rights have transferred are "eligible students." <u>Additional information on FERPA</u>

The Family Educational Rights and Privacy Act (FERPA)

Guidelines to keep in mind about FERPA and instructor-parent communication:

- Instructors and other college staff cannot communicate with parents about a student's educational records in person, via email, or by phone.
- Grade appeals and student complaints **must** be handled by the student and communicated by the student to the instructor, department chair, or dean.
- Parents **should not** come to the instructor's classroom or office in hopes of discussing a student's work.

Academic Standing Policy

Bellevue College is committed to the academic success of its students. The college identifies and alerts students who are not making satisfactory academic progress and provides those students with assistance to improve their academic performance. The Academic Standing Policy applies to all students, with limited exceptions. <u>3200P Academic Standing (Procedures)</u>

Academic Standing Procedures:

Students must earn a **cumulative** and **quarterly** Grade Point Average (GPA) of 2.0 or higher to remain in good academic standing and off of academic probation. The college applies progressive consequences for students who do not achieve a good academic standing at the end of each quarter.

Academic Standing Levels:

- Level 1: Academic Concern
- Level 2: Academic Intervention
- Level 3: Academic Restriction
- Level 4: Academic Dismissal

Title IX

Title IX of the Education Amendments of 1972 (20 U.S.C. § 1681) is an all-<u>encompassing federal law</u> <u>that prohibits gender-based discrimination in educational institutions</u> that receive federal funds.

Title IX is most associated with gender discrimination in sports and is credited with advancing participation of women in athletics. However, the scope of Title IX is much broader. *It prohibits sex and gender-based discrimination in all college programs and activities.*

Title IX *protection from discrimination extends to faculty, staff and students* and includes such things as: sexual harassment, dating violence, domestic violence, stalking, gender-identity sexual violence and pregnancy. It also prohibits retaliation against anyone who makes or participates in a complaint.

Title IX

Title IX is a federal civil right that prohibits gender-based discrimination.

Protections from gender-based or sex-based discrimination are extended to all people on campus regardless of their real or perceived sex, gender identity or gender expression.

Areas covered under Title IX include such things as:

- Gender Discrimination, including Gender
- Identity Sexual Harassment
- Dating & Domestic Violence Sexual Assault
- Pregnancy

*Retaliation directed at anyone who makes a complaint or participates in an investigation is strictly prohibited.

Anyone can report a concern about sexual harassment, sexual misconduct or gender discrimination that impacts a person at Bellevue College. Bellevue College offers multiple points of contact for Title IX concerns and reporting. The College will seek to protect the privacy of the complainant to the full extent possible; however, the only office that can guarantee confidentiality, except as mandated by Washington State Law, is the Counseling Center. **All other employees are required to report Title IX concerns**.

Disability Resource Center

The Disability Resource Center (DRC) at Bellevue College fosters transformational change to present disability as a valued part of life. DRC provides a wide variety of accommodation services for students, and work to educate the community and foster inclusiveness.

New Running Start Students need to know:

High school students with an IEP or a 504 plan, or struggling in their courses due to physical or mental health reasons, **may be eligible for accommodations** at Bellevue College through the DRC.

- High school accommodations are different from college accommodations.
- Accommodations must be arranged each quarter through the DRC by the student.
- Meet with the DRC to learn more about what your accommodations could be.

Information regarding your disability is confidential! This means registration with the DRC will not go on any transcripts, will not be shared with other colleges or universities, and is generally not shared with faculty, staff, or other students until you give us permission. We also never share your disability diagnosis, only DRC registration status and accommodation information.

Our office supports students in all High School Programs such as Running Start. Please note IEP/504/accommodations are not automatically transferred to college; you must complete our registration process.

The college might accept Individualized Education Plan (IEP) and 504 plans for documentation but college accommodations are different from high school. <u>Review accommodation differences from</u> <u>secondary school to high education (Links to an external site) to be prepared</u>. These differences will be discussed during our registration process if you have any questions.

Regardless of what medical documentation you may or may not have, please contact our office to have a discussion about how we may be able to support your academic goals. Obtaining documentation may be difficult and want to work with you regardless of what documentation you may or may not have.

- It can take our office up to 10 business days to process forms; and are processed in the order received
- Students will not be coded as a Running Start student until the EVF is processed

Students may qualify for the Fee Waiver if they receive any of the following:

- Free/reduced meal program
- TANF Benefit Statement
- Foster Youth
- Medicaid ID Card and Statement
- Basic Food Statement
- Other State and Federal Supported Programs

Fee Waiver

The fee waiver covers the student fees and class fees for the number of credits approved on the students Running Start Enrollment Verification From.

Below is a list of some items that are not covered by the Running Start Fee Waiver:

- Consumable fees, specifically digital material fees, or rented equipment
- Below 100 level classes
- Tuition for classes if the student chooses to enroll in MORE credits than approved on their RSEVF form
- Placement fees
- Cost of ordering BC official transcript/s
- Any fines
- Meals at the college
- Transportation unless otherwise specified
- Laptops or other materials that are usually provided by high schools

Running Start New Student Orientation (RS-NSO)

Our Running Start New Student Orientation (RS-NSO) is designed to help students achieve success at Bellevue College. This is a one-time, mandatory requirement to be completed before a student can enroll/register for classes.

- There is a block/hold on the students account which prevents enrolling/registering for classes until the RS-NSO step is completed. The Running Start Office will review the students completed RS-NSO within a week's time after completion and then remove the block/hold.
- New students will need to self-register and complete the RS-NSO. Please access this link to register for the RS-NSO <u>https://bc.instructure.com/enroll/YXPGH9</u>.

Registration

- New Students (your first ever quarter registering in classes at BC): Open Registration
 Open registration means that new students are not assigned a specific date and time to register and
 can register beginning on the first day of Open Registration, if all the required RS and college
 admissions have been completed.
- Returning Students (after your first quarter at BC): Assigned Registration Date & Time
 Returning students will need to check their specific registration date and time through Online
 Services. These dates maybe not be available until a few weeks before registration week begins. Note:
 Please submit your Running Start Enrollment Verification Form 10 business days prior to the start of
 each quarter. RS enrollment verification forms are processed in the or they are received.

Registration

- Running Start students have the same registration process as all BC students. Enrollment in classes that you may need for High School graduation is not a guarantee.
- Running Start students can register for any course offered at BC if they meet the **prerequisites** and required **placement** for the course.
- A *Prerequisite* is a requirement that must be met before you can take a course. This is always listed on the course catalog below the class title, if there is a prerequisite for the course.
- *Example*: If a student wishes to enroll in English 101 they must have placement scores in the BC system for English 101 or have taken and passed English 092 or 093 with a C- or better. A student may only enroll in English 101 if they meet the prerequisites listed.

Permission Numbers

You may need a permission number to enroll if:

- Class is full
- Waitlist is closed
- Open enrollment is closed
- Requires instructor's permission
- To override a course prerequisite
- Class enrollment is a specific program at the college

Keep in Mind:

- If permission number is needed af*ter you click "save,"* then an additional message pops up
- If permission number is *not* needed, then you can simply leave the box blank and proceed with the enrollment process
- Contact instructor listed for the class to obtain number
- Instructors are not required to give you a permission number

Waitlists

- If you register for a course section that is full you may be placed on a **waitlist**. We highly recommend student enroll in classes with open seats and avoid the wait-list.
- If you are on the wait list, you are not charged for the course. Meaning if you are added off the waitlist you will then be charged for the course.

Rules of the Waitlist:

- Some courses do not allow waitlist
- You may only have up to 6 credits for a waitlist
- The maximum number of space on a waitlist is 5 students
- You may not enroll in a course and be on a waitlist for the SAME course
- There is never a guarantee that you will get into the course off the waitlist
