A number of online forms are available to share a student concern with the campus offices dedicated to support student success. Any BC Community member can share a concern.

# **Example Concerns**

The following examples include concerns that could be submitted for each report type, but the list is not exhaustive. Early Alert concerns can be submitted during weeks 1 through 5 of each quarter. # **Early Alert**

- Failure to log into Canvas or stopped logging on
- Never attended class or stopped attending
- Decline in the quality of work or class participation
- Repeat absence

#### Title IX\*

- Sexual or gender-based harassment
- Dating and domestic violence
- Stalking (including cyberstalking)
- Sexual assault

### Bias Incident or Hate Crime

- Hate based graffiti
- Bias motivated threats or violence
- Behaviors motivated in whole or in part by the offender's bias towards the victim's status based on race, color, religion, ethnic/national origin, gender expression, sex, age, disability or sexual orientation identities

# **CARE Team Referral\***

- Self-disclosure of personal distress
- Food or housing insecurity
- Suicidal thoughts/ideation
- Inappropriate emotional outbursts
- Expressions of concern about the student by peers

## Student Conduct\*

- Highly disruptive behavior (e.g. hostility, aggression)
- Verbal abuse (e.g., taunting, intimidation)
- Inappropriate communications (e.g. threatening letters, e-mail messages, harassment)

### **Academic Dishonesty**

- Cheating on a test or quiz
- Plagiarism in a paper or on a course discussion board
- Fabricating data for an academic assignment.

\* In an emergency, call 911
