



# Skills for Work Camp for Young Adults with Disabilities

## **Terms of Agreement**

### Eligibility

In order to benefit from our curriculum and engage in the group activities that are integral part of the learning process, campers must be High School or Transition students, ages 16 to 19 (ages 19 to 21 will be considered on a case by case basis), with at least 60 IQ or higher intellectual functioning. OLS staff is not licensed nor certified to provide any kind of personal care (including but not limited to feeding, medicating, toileting or transporting).

### **Behavior/Conduct Expectations:**

In an effort to provide all campers with a safe and educational experience, it is important that all participants exhibit proper behavior and self-control, consistent with acceptable workplace standards. Participants are expected to respect camp staff and fellow participants at all times. Inappropriate, sexual, disruptive and/or violent behavior while in the camp will not be tolerated. Examples of inappropriate behavior include, but are not limited to, fighting, name calling, bullying, destruction of property, disrespectful or illegal actions, and inappropriate physical contact. Our staff reserves the right, upon notification of the parent/guardian and, to dismiss any participant for conduct deemed detrimental to the well-being of other participants, staff, or to the overall operation of the camp. Refunds will not be given should this occur.

## What are the qualifications of the staff leading the program?

Each camp will be led by two OLS experienced staff with extensive experience in education or employment services.

Student/instructor ratio is 6:1.

## Transportation

Campers or their families are responsible for arranging their own transportation to and from the program site





#### Arrivals and Departures

**Drop-Off** will take place from **8:30am-9:00am** each day. Participants should not be dropped or arrive prior to 8:30 am as supervision will not be provided. Staff is not expected to be on site until 8:30 am. A parent or other authorized person may accompany the participant inside the building or they may drop them off outside.

**Pick-Up** will begin at the program site, at 12:00 pm and end at 12:30 pm. Participants must be picked up prior to 12:30 pm as supervision will not be provided past 12:30 pm for any reason.

Only parents/guardians or other specifically authorized persons may pick up under age camp participants.

#### Attendance:

If the camper will not attend on a specific day for which he or she is registered, please notify OLS staff at 425 564 5206 as soon as possible. Refunds will not be given for any missed days, for any reason, due to the need for consistent staff supervision regardless of the number of participants.

#### In Case of an Emergency:

If you need to reach program staff or a participant during the day, please contact 425 564 5206. The person at this number will assist you in contacting the appropriate program staff. However, if an injury or illness occurs, the participants' parent/guardian will be immediately notified.
