# **Course Information**

Abnormal Psychology, Psychology 220 Meeting times: T/Th 10:30 – 12:20, with online component (hybrid course) Meeting location: R210

# **Course Outcomes**

Introduces the theories, diagnosis, and treatment of maladaptive behavior and psychological disorders. Class format may include field trips to psychiatric institutions. Prerequisite: PSYC 100.

# How Outcomes Will be Met

Through lecture, in-class exercises, and online projects, by the end of the course I expect you (the student) will be able to:

- 1. Analyze the causes, prevention, and treatment of psychological disorders.
- 2. Distinguish abnormal from "normal" behavior.
- 3. Define issues related to the diagnosis and classification of behavior problems in adults and children.

4. List up-to-date descriptive information about the symptoms, prevalence, risk factors, and course of treatment for different psychological disorders.

5. Describe different theoretical perspectives of abnormal behavior.

6. Identify the hypothesized or known causes and treatments offered by each theoretical perspective.

7. Identify different scientific methodologies used in current research to study abnormal behavior.

# Grading

Your grade in this class will be based on online discussion boards, papers, and exams.

Online Discussion Boards (30%): Each week, you will go to our class website (via Canvas) to watch videos of individuals with various forms of psychopathology. After watching these videos, you will be expected to contribute to a class discussion board on each video. For example, when discussing childhood disorders, you will watch a video of a child with ADHD, a child with autism, and a child with conduct disorder. There will be 3 separate discussion board threads for you to comment on each of these videos. Comments may address symptoms, treatment, or any other key features of the video (i.e., educational options, parental reactions, treatment possibilities). The goal of

these discussion boards is for you to have an opportunity to engage with the material and see real life examples of various forms of psychopathology. Each week, you will be expected to make (at least) three comments (1 per each video). Responding to other comments is acceptable so long as comments are thoughtful. For example, a simple "Yes" or "I agree" response comment will not get any points. Each week, you may earn up to 10 points for discussion board comments. These comment forums will be helpful sources of information as you work on your papers (see subsequent paragraph). Responses are due at 5 pm on the Thursday of that week of class.

# 10 points possible for each discussion board activity X 6 assignments = 60 points possible

<u>Paper (20%)</u>: There will be 2 one-page (single spaced) papers required for this class. In these papers, you will select one of the online videos of an individual with psychopathology and write an evaluation of their symptoms. The goal of this paper is to (a) demonstrate knowledge of the definition and key symptoms of a disorder, (b) describe the symptoms of psychopathology of the specific individual as well as any specific features of interest, and (c) describe possible treatment possibilities. The goal of this paper is to demonstrate knowledge of a disorder, critically evaluate a video for a person's specific symptoms, and apply possible treatment options of the disorder.

A handout with detailed instructions on the paper will provided a few weeks into the term.

Paper 1: Any videos from 9/21 - 10/15. Paper 2: Any videos from 11/3 - 11/24.

# 20 points possible for each paper X 2 papers = 40 points possible.

<u>Exams (50%)</u>: Two exams will be given. Each exam will cover assigned reading material (whether or not it has been covered during class), class lectures, and any films shown. Exams will draw from both the in-class and online portions of class. Each exam will consist of multiple-choice questions, fill-in-the-blank questions, and short essays. Sample questions can be discussed in class or during review sessions to give students a chance to become familiar with the types of questions given on the exams. The exams will last the class period.

50 points possible for each exam X 2 exams = 100 points possible.

*Make up exams will not be given.* In the event of extreme circumstances the professor must be notified prior to the exam and a replacement, all essay exam will be given if warranted (per the discretion of the Instructor).

The final grade will be calculated: Online discussion board grade (out of 60 possible points) + Paper grades (out of 40 possible points) + Exam grades (out of 100 possible points) / 200 = Your grade.

## **Classroom Learning Atmosphere**

In order to maximize course time, I expect all students to have read the chapter prior to class. In addition, all students should come prepared to talk, respond to questions, and participate in in-class activities that cover the topic of the day.

<u>Readings</u>: Assigned chapters are listed on the course schedule. Lectures will relate to the text and build on the subject for each class (e.g., case examples, research findings, discussion of controversial issues).

<u>Class Participation & Attendance</u>: Because issues related to abnormal psychology are frequently value-laden, students will be asked to exercise mature decision-making skills throughout the course. In order to make class discussions interesting and enjoyable for everyone, class participation is expected and encouraged. Attendance will not be taken, and each student will be responsible for the material covered in class, regardless of attendance. If a student misses a class, the discussion that occurs in class will not be outlined or presented outside of class. Therefore, if you miss class, it is the students' responsibility to contact a classmate to get notes, read the chapter and be sure you understand the class notes and text material, and then me if you have questions. *Email Communication* with instructors must be done through student email accounts only. Instructors cannot communicate with students about their course work or grades through student's personal email accounts.

#### Incomplete

If a student fails to complete all the required work for a course, an instructor may assign the grade of Incomplete ("I"). The student must complete the coursework by the end of the next quarter, or receive the assigned letter grade (usually an "F").

## F Grade

Students who fail a course will receive a letter grade of "F."

## Final Examination Schedule

The Social Science Division will adhere to the final examination schedule as stated in the BC Schedule. Final examinations will be held at the end of each quarter at fixed times. Instructors will not give examinations in advance of the regular schedule. A student who is absent from any examination held at any time during the quarter may forfeit the right to make up the examination. If, for illness or some other circumstance beyond the student's control, the student is unable to be present at any scheduled examination and has contacted the instructor on a timely basis, the student may be permitted to take such examination at a time designated by the instructor.

#### Withdrawal From Class

College policy states that students must formally withdraw from a class by the end of the seventh week of the quarter (Registration Office, B125). If a student has not withdrawn by that date, an appropriate letter grade will be assigned for the course.

#### Hardship Withdrawal

Instructors may assign the grade of "HW" (hardship withdrawal) at their discretion in the event that a student cannot complete the coursework due to extreme and exceptional circumstances. Students may also contact the Enrollment Services office BEFORE grades are assigned in cases of hardship.
