<u>Course Description</u>: This course introduces basic concepts, theories, principles and an historical overview of the criminal process as they relate to the formal and informal adjudication of violent, serious, and chronic juvenile offenders. Prerequisite: CJ& 101 recommended.

Learning Outcomes:

Successful students will be able to:

- 1. Distinguish the important differences between the adult and juvenile justice systems.
- 2. Identify the nine Supreme Court cases which have shaped critical issues in the Juvenile Justice System.
- 3. Identify important milestones in the development of the Juvenile Justice System.
- 4. Identify the basic procedures associated with the adjudication of Juvenile court cases.
- 5. Recognize and understand the problems and issues associated measuring Juvenile Crime and Victimization.
- 6. Identify the important aspects of the Diversion and Intake process of Juvenile Justice.
- 7. Identify and discuss the goals and processes of Juvenile Probation and Parole.

Paper Requirements:

You will have a paper submission, it should be 4-5 pages in length (cover page and reference page(s) do not count), 12 point font (Times New Roman), 1 inch margins, and MUST have a cover page and references page. The paper must be on a topic within the area of criminal justice. You <u>CANNOT USE</u> Wikipedia for a reference since it is not peer reviewed (see me for all sources that you are unsure about using). The paper has to be turned in hardcopy by Friday, June 6th at the beginning of class. The paper is worth 100 points. Plagiarism will result in a 0 grade and potential academic consequences.

F Grade:

Final Examination Schedule:
