Course Information

Economics provides a useful perspective and set of tools for analyzing and interpreting the world around us. Economics 202, a macroeconomics course, focuses on the economy as a whole and the relationship of economies with one another. The course presents major theories of business cycles and economic growth. We will examine why the economy fluctuates, how the nation's economic output is measured, what determines the rate of unemployment, and what

determines the rate of inflation. Students will examine economic policies aimed at price stability and unemployment in an industrialized capitalist nation as well as factors in international trade and monetary flows. We will also look at the factors that determine long-term growth. With global economic health currently in question, this is a great time to study economics. We will spend considerable time in this class applying the concepts we learn to our current (and other historical) economic situations.

Learning Outcomes and Goals:

After completing this class, students should be able to:

- Acquire and critique the use of primary source statistics in assessing the health of a macroeconomy.
- Explain the relationships between economic growth, unemployment, and inflation.
- Recognize the importance of the Federal Reserve's regulatory role in money and banking.
- Evaluate the pros and cons of proposed macroeconomic stabilization policy.
- Examine factors that influence long-run growth and productivity.
- Describe how the internationalization of our economy has changed the outcomes and choices of our domestic economy.
- Critically analyze the positive and negative impacts of markets as they relate to social justice and environmental issues.
- Represent and understand economic concepts and outcomes in numerical and graphical form.

Canvas Instructions

We will be using the online learning management system called Canvas, which can be accessed at <https://bc.instructure.com>. You should use your BC login and password. Required Text and Resources

Macroeconomics by Paul Krugman and Robin Wells, 2nd edition

The textbook we will be using for this course is *Macroeconomics* by Paul Krugman and Robin Wells (second edition). **Please note that we are using the 2nd edition of the book to provide you with more affordable options to access the textbook, but you may also use the 3rd edition if you prefer as long as you recognized the different numbering of the chapters.** You will be required to purchase access to Sapling Learning for the quarter, an online

homework system. You can buy this textbook from the bookstore or even a used copy on Amazon.com for around \$10 (ISBN: 9780716771616), and pair it with access to Sapling, which can be purchased online at www.saplinglearning.com for \$24.99 for the quarter. There are a few copies of the textbook on reserve at the library for short-term use. You have the option to bundle an electronic copy of the textbook with Sapling if you are comfortable with reading books online:

Macroeconomics Ebook+Sapling Access Card (ISBN: 9781464137297)

This option is the Ebook with the access card to the online homework system we will be using. **Please use a coin and rub gently when removing the silver strip.** There have been reports that the entire access code can be removed if using a key or other sharp metal object.

The Sapling Access Code For Either Micro Or Macro Econ. (ISBN: 9780983385950)

This option is just the access code for the online homework system, in case you would like to buy a physical copy of the book (they are available used at the bookstore or even used from Amazon.com for around \$10) or use the copy on reserve in the library.

Sapling Instructions

1. Go to <http://saplinglearning.com>
2. If you already have a Sapling Learning account, log in then skip to step 5.
3. If you have Facebook account, you can use it to quickly create a SaplingLearning account. Click "create account" located under the username box, then click "Login with Facebook". The form will auto-fill with information from your Facebook account (you may need to log into Facebook in the popup window first). Choose a password, fill in the remaining information, accept the site policy agreement, and then click "Create my new account". You can then skip to step 5.
4. Otherwise, click "create account" located under the username box. Supply the requested information and click "Create my new account". Check your email (and spam inbox) for a message from Sapling Learning and click on the link provided in that email to confirm your account.
5. Find your course in the expandable list (sorted by subject, term, and instructor) and click the title link. Key code is "OAS" if you registered for section OAS, "OBS" if you registered for section OBS.
6. Select a payment option.

Once you have registered and enrolled, you can log in at any time to complete or review your homework assignments. During sign up - and throughout the term - if you have any technical problems or grading issues, send an email to support@saplinglearning.com explaining the issue. The Sapling support team is almost always more able (and faster) to resolve issues than your instructor.

Student Responsibilities

Grading Policy

The best way to learn economics is by doing, not by memorizing. There will be a variety of homework assignments, exams, and activities in which students will demonstrate how they have learned to implement economic reasoning and analysis. Grades will be assigned according to the following grading scale:

Sapling Problem Sets

The graded problem sets should be completed individually (although students will have access to their textbooks as a resource during these assessments). The graded problem sets have a firm due date. In other words, Sapling assignments must be completed by the due date. The software does not care whether you have an excuse or not. These assignments are posted weeks in advance. Do them early to avoid any emergencies preventing your completion before the due date. For each of the graded problem sets, you have an unlimited number of attempts at the problem, but each attempt you make reduces your score on that problem by 5%.

Students begin the quarter with **2 Free Passes** for homework assignments. The top grades will be counted, and the two lowest grades will be dropped. Since the 2 lowest scores are dropped, and since the materials are available well in advance, no missing assignments will be made up for any reason, even those that are not the student's "fault", including computer glitches, illness, travel, burglary, etc.

Assignments

There will be a number of [Assignments](#) throughout the quarter. These activities are designed for the application of economic concepts and theories to real world examples. These assignments will vary each week and will be submitted in Canvas. You can find links to the assignments under each week, or you can go to the "Assignments" tab in the left-hand navigation to see a list of all assignments to date.

Online Discussions

We will participate in weekly discussion boards administered in Canvas. Every week the instructor will post one or more questions to which you will post your own individual response by Friday of that week. Your post should be reflective and demonstrate your understanding of our course materials. In addition, you must read all of the posts from your classmates and reply to at least two posts from your peers by the following Monday. Your replies should be substantive and add to the conversation by responding to their post, posing further questions for inquiry, or correcting false information. Replies like "I agree" or "Great post" are insufficient replies because they do not engage with the original post. The grading rubric for the online discussions is available in Canvas.

Whether in the physical classroom or in the virtual classroom, it is important to respect the diverse perspectives, experiences, and feelings of others in the classroom.

Papers

You will write two papers throughout the quarter that explain how the economic concepts of the textbook and class can be applied to current events articles. More information about the papers including guidelines and rubrics can be found on Canvas. The due dates for the papers are May 8th for Paper 1 and June 9th for Paper 2.

Exams (on Canvas)

The three exams will be completed in Canvas. They are comprised of multiple choice and short answer questions. Exam 1 is to be completed by April 28th. Exam 2 is to be completed by May 19th. Exam 3 is to be completed by June 17th.

Preventing Plagiarism

Plagiarism is a form of academic dishonesty occurring when students use information or material from outside sources without properly citing them. This is grounds for disciplinary action. It is your responsibility to understand plagiarism and its consequences. Plagiarism occurs if:

- You do not cite quotations and/or attribute borrowed ideas.
- You fail to enclose borrowed language in quotation marks.
- You do not write summaries and paraphrases in your own words and/or do not document your source.
- You turn in work created by another person.
- You submit or use your own prior work for a current or past course, or work from one current course in another course *without express permission* from your professors. This may also be considered academic dishonesty.

In order to help identify (and therefore hopefully avoid) plagiarism, we will be using a service called **turnitin.com**, which checks your written work against other sources to check for originality. You can check your originality score after you submit your written work in Canvas.

If it is determined that you have plagiarized or engaged in other forms of academic dishonesty, you will fail the assignment and possibly the course, despite points earned through other work. Acts of academic dishonesty are reviewed for disciplinary action.

Bellevue College's Affirmation of Inclusion

Incomplete

If a student fails to complete all the required work for a course, an instructor may assign the grade of Incomplete ("I"). It is the student's responsibility for maintaining contact and adhering to the agreed-upon actions. Vista class sites, and material, may not be directly accessible after the end of the quarter so it important to make arrangements before the quarter ends. The student must complete the coursework by the end of the next quarter, or receive the assigned letter grade (usually an "F"). There is a standard form that instructors have access to in their instructor's grade briefcase.

F Grade

Students who fail a course will receive a letter grade of "F."

Final Examination Schedule

Please refer to the syllabus at the start of the quarter for additional details and contact the instructor directly for any clarifications. A student who is not in compliance with the scheduled format may forfeit the right to make up the examination. If, for illness or some other circumstance beyond the student's control, the student is unable to be in compliance with any scheduled examination and has contacted the instructor on a timely basis, the student may be permitted to take such examination at a time designated by the instructor.

Withdrawal From Class

Academic Year: College policy states that students must formally withdraw from a class by the end of the seventh week of the quarter (Registration Office, B125). If a student has not withdrawn by that date, an appropriate letter grade will be assigned for the course.

Summer Quarter: College policy states that students must formally withdraw from a class by the end of the fifth week of the quarter (Registration Office, B125). After the sixth day and through the end of the fifth week of the quarter, the "W" grade will become part of the student's transcript record.

Hardship Withdrawal (HW)

From page 9 of the current course catalog, [2008-2009 online catalog](#), HW indicates a withdrawal request made because of extenuating circumstances after the official withdrawal period is over. The student must contact the instructor to request this withdrawal option, or the faculty member may initiate the contact. No points are calculated into the grade-point average. Students may also contact the Enrollment Services office BEFORE grades are assigned in cases of hardship.

Students Who Require Disability Accommodations:
