## **Course Information**

## **Course Description**

This course surveys the field of social psychology: the scientific study of how people think about, influence, and relate to one another. Emphasis is on the interaction of the social environment with intra-psychic processes as determinants of attitudes, perception, personality, and behavior.

## **Course Learning Objectives**

Upon completion of this course, students will be able to:

- 1. Identify and critique the research methods social psychologists use.
- 2. Explain how social cognition influences beliefs, perceptions, explanations, and attitudes.
- 3. Describe psychological and social influences on the following attitudes and behaviors: Conformity and obedience, Aggression, Group influence, Attraction, Prejudice, and
- 4. Apply research findings in social psychology to the mental health and court systems.
- 5. Design simple psychological research projects involving data collection an write-ups

### Course Work

#### Exams

Multiple-Choice Exams Throughout the quarter, we will cover all nine chapters in your text. For each chapter, there will be an online multiple-choice exam, worth 20 points each. While these weekly exams will be completed online on Canvas, they are not considered open-book. If you have difficulty taking multiple-choice exams online, you will be allowed to take a paper exam during office hours.

Written Exams There will be three in-class written exams throughout the quarter. In total, these will be worth 400 points, with the first two worth 125 points each and the third worth 150 points. Each will cover information from the text, class lecture, and videos. With each exam, you can expect to make connections between the lecture material and your life by coming up with real-life examples. The exams may consist of multiple-choice questions, essay questions, matching items, and/or labeling. You will be provided a study guide for the written exams.

Exams will not be given late. If you know ahead of time that you will be unable to attend class on any exam day, you may make arrangements with me to take an alternative exam early. If you come late to class on an exam day, you will not be given additional time. Make-up exams may be allowed with appropriate documentation. All exams given outside of class must be taken during office hours. See the Class Calendar for tentative exam dates.

## Clipping File

Throughout the quarter, you will create a *clipping file* by collecting a variety of *current* newspaper, magazine, and comic strip artifacts that illustrate different concepts in social psychology. With each artifact, you will describe in detail the concept at hand and how it relates to your chosen artifact, thereby demonstrating your understanding of the concept. Your file will be worth a total of 225 points and completed in multiple parts. Details and scoring criteria will be posted on the class site on Canvas. See the Class Calendar for the due date.

## Reflective Paper

Throughout the quarter, you will view a few documentaries, both online and in class. Relating the documentaries to your text, you will complete a reflective paper worth 100 points. Details and scoring criteria will be posted on the class site on Canvas. Late assignments will be accepted only within 24 hours of the due date and at penalty of 20% off the total points possible. See the Class Calendar for all due dates.

#### **Attendance**

Attendance will be taken in the form of in-class activities worth, in total, 90 points. If you are not in class, you cannot participate; if you do not participate, you will not receive credit for in-class activities.

#### Extra Credit

There may be limited opportunities to earn extra credit for this course. These opportunities may consist of outside activities (e.g., attending a campus lecture or workshop) and written papers pertaining to the topics covered in this course. Such opportunities will only be announced in class.

## Classroom Learning Atmosphere

## Instructor's Expectations

You are about to learn about many theories seeking to explain why people do the things they do. Beyond acquiring new knowledge, my goals for you include development of critical thinking skills (how to effectively evaluate everyday information) and the ability to apply concepts in psychology to situations beyond the classroom. You will learn new material every week through a combination of lecture, whole-class discussion, and small group activities. To complement that, each week, you'll take an online quiz to assess what you've learned that week.

**Hybrid Course** As a hybrid, this course includes both on-line and on-ground components. To succeed in this class, you must have regularly access to a computer with Internet access. If you do not have access to a computer with Internet access, an open computer lab is available in N250 to all BC credit students.

Come Prepared As a college student, you are responsible for your own education. Be an active participant. It is up to you to stay on schedule, to adhere to due dates, to plan ahead, and to ask questions when in doubt. If you have questions about the class, read this syllabus first; if you do not find the answer there, ask. Always ask. You will be expected to read the book before class, take lecture notes, think about the stuff you read, and come prepared to discuss these ideas with your professor and peers. Participation will be encouraged. Challenge assumptions. Consider the implications and applications of this course material. Some theories or evidence may appear counterintuitive and may provoke much reaction, sparking lively discussions. Within these

discussions, it is important to remain respectful of your peers; everyone has a point of view. While discussion is encouraged and will be solicited, side comments and off-topic talk will not be tolerated.

**Study effectively**. Read the material, trying to understand the underlying ideas. Study concepts you do not understand. Think deeply about the course material; this will not only help you remember it better, it will make it more useful for the future. Form study groups with your classmates. Ask for help right away if you need it; BC has a tutoring center and the library has areas for study groups. This class goes quickly, and you'll need to stay on top of the reading to do well.

**Punctuality** is expected. Please be on time for class. Arriving late or leaving early undoubtedly breaks the flow of the class and causes a distraction. If you arrive late, please take a seat close to the door. If you need to leave early, make arrangements with me ahead of time and sit close to the door.

Attendance is not optional. As adult students, you are expected to manage your own time and priorities. If you miss any class sessions, you are responsible for obtaining any lecture notes from fellow students, missed assignments from me, and for staying abreast of any class announcements or changes to the class schedule. Emailing me of your absence is appreciated. Note: when emailing me outside of Canvas, please include your full name and class section; in the email subject line, it is helpful to start with "STUDENT" so that it does not get lost in the melee of emails.

# PROCEDURES & GUIDELINES OF THE SOCIAL SCIENCE DIVISION Winter 2016

## Cheating, Stealing and Plagiarizing\*

Cheating, stealing and plagiarizing (using the ideas or words of another as one's own without crediting the source) and inappropriate/disruptive classroom behavior are violations of the Student Code of Conduct at Bellevue College. Examples of unacceptable behavior include, but are not limited to: talking out of turn, arriving late or leaving early without a valid reason, allowing cell phones/pagers to ring, and inappropriate behavior toward the instructor or classmates. The instructor can refer any violation of the Student Code of Conduct to the Dean of Student Services for possible probation or suspension from Bellevue College. Specific student rights, responsibilities and appeal procedures are listed in the Student Code of Conduct, available in the office of the Dean of Student Services and at

**Email Communication** with instructors must be done through student email accounts only. Instructors cannot communicate with students about their course work or grades through student's personal email accounts.

## Incomplete

If a student fails to complete all the required work for a course, an instructor may assign the grade of Incomplete ("I"). The student must complete the coursework by the end of the next quarter, or receive the assigned letter grade (usually an "F").

#### F Grade

Students who fail a course will receive a letter grade of "F."

### Final Examination Schedule

The Social Science Division will adhere to the final examination schedule as stated in the BC Schedule. Final examinations will be held at the end of each quarter at fixed times. Instructors will not give examinations in advance of the regular schedule. A student who is absent from any examination held at any time during the quarter may forfeit the right to make up the examination. If, for illness or some other circumstance beyond the student's control, the student is unable to be present at any scheduled examination and has contacted the instructor on a timely basis, the student may be permitted to take such examination at a time designated by the instructor.

#### Withdrawal From Class

College policy states that students must formally withdraw from a class by the end of the seventh week of the quarter (Registration Office, B125). If a student has not withdrawn by that date, an appropriate letter grade will be assigned for the course.

## Hardship Withdrawal

Instructors may assign the grade of "HW" (hardship withdrawal) at their discretion in the event that a student cannot complete the coursework due to extreme and exceptional

circumstances. Students may also contact the Enrollment Services office BEFORE grades are assigned in cases of hardship.

## Students Who Require Disability Accommodations

Students with disabilities who have accommodation needs are encouraged to meet with the Disability Resource Center (DRC) office located in B132 (telephone 425.564.2498 or TTY 425.564.4110), to establish their eligibility for accommodation. The DRC office will provide each eligible student with an accommodation letter. Students who require accommodation in class should review the DRC accommodation letter with each instructor during the first week of the quarter.

Students with mobility challenges who may need assistance in case of an emergency situation or evacuation should register with Disability Resource Center and review those needs with the instructor as well.

#### **Distribution of Grades**

Grades will not be posted in the Social Science Division or in faculty offices, and program assistants or coordinators will not give out grades. Students should access their grades through the BC Web site.

## **Return of Papers and Tests**

Paper and/or Scantron score sheet returns will be arranged in the following ways ONLY: by mail, if student supplies the instructor with stamped, self-addressed envelope (with appropriate postage); or by the instructor designating a time and place whereby the student may retrieve his/her papers. Unclaimed papers and/or Scantron score sheets must be kept by the instructor for a minimum of sixty (60) instructional days following the end of the quarter.
