Course Information

Course Outcomes

- Understand cost accounting terms, concepts, cost classifications and behavior.
- Understand traditional job and process cost accounting systems.
- Prepare operating budgets and analyse variances to the budget.
- Prepare capital budgeting analysis, with emphasis on discounted cash flow methods.
- Prepare and present analysis using accounting information to support various operating and financing decisions.

This class prepares students to take intermediate level accounting courses and the credits are transferable to most 4-year degree institutions.

How Outcomes will be met

This course covers analysis and evaluation of accounting information as part of the control, planning, and decision-making processes. Focus is on the use of information by business managers and decision makers. Students will present and discuss managerial accounting cases in class and create an Excel workbook of selected managerial accounting decision templates and an integrated set of proforma financial statements.
