# **Course Catalog Description**

Uses an interdisciplinary, multimedia approach to examine the history, culture, religions, institutions, politics, economics, and arts of peoples of African descent in the United States. Focus is on U.S. life from a Black perspective, examining both historical and contemporary works.

## **Course Content**

In this course we will study a broad range of topics—some of which will include provocative content and adult themes. While every attempt will be made to keep things PG-13, please know that there will be times where R-rated content is necessary to examine course topics within an academic context. Students will not be penalized for excusing themselves from content they find objectionable or difficult to watch, see, discuss or listen to. That being said, students who excuse themselves are responsible for any course material they miss as a result of choosing not to participate.
