Learning Outcomes:

At the conclusion of this course, successful students will be able to:

- Define and explain the significance of key facts and events of the period under study, and develop criteria to judge events, people, and processes from an historicalcultural perspective.
- 2. Determine an historical thesis and judge the appropriateness of both the argument and its development.
- 3. Adapt scholarly processes of analysis, interpretation, and synthesis to articulate an original point of view demonstrating a command of relevant facts and a framework of logical deduction.
 - Drawing inferences from discrete data
 - Differentiating between facts, value judgments, and generalizations
 - Differentiating between description and explanation
 - Synthesizing data and interpretation
 - Recognizing the role of cause and effect in historical analysis and avoiding post hoc ergo propter hoc fallacies.
- 4. Expand their vocabulary
- 5. Demonstrate the importance of traditions of thought and ethical values in the process of historical change.

Course content and objectives:

History 103 is a survey of global civilization from the French Revolution to the present. The course examines the major developments that have shaped world history since the end of the 18th century. These include the ideas of the French Revolution and their impact; the industrial revolution, and the spread of technological culture; major cultural and intellectual trends and responses to a changing world; economic history; gender history, the growth of modern

ideologies, including Marxism, liberalism, nationalism, socialism; Nazism, Fascism, and the development of totalitarian government; military history, imperialism and de-colonization, and the shifting balance of political power.

This course seeks to provide an understanding of the comparative features of modern civilizations, an appreciation of important personalities and events that shaped the contemporary world as well as an understanding of the impact of the 19th and 20th century developments on the lives of ordinary men and women. The course should help students understand the nature of the problems facing the contemporary world.

Teaching methods:

This course is taught primarily by lectures and discussions, but will include audio/visual material when appropriate. Discussions will take place for one class period each week. Students are encouraged to raise questions based upon their work with the texts and their appreciation of class discussion at any time.

This course requires each student to undertake independent work virtually on a daily basis. Work methods for this course resemble those that would be applied in the study of a foreign language. The study of history is cumulative. Since issues and events are presented as relational, it is fundamental to the success of a student to ensure that the reading assignments and other work will be accomplished in a timely fashion so that students will gain a coherent accumulation of relevant data as method of analysis and argument are introduced. Students are expected to work about two hours each day outside of class. This course requires college level literacy and hence the ability to communicate ideas and facts clearly and accurately. This forms a central goal of the teaching/learning and assessment process in this course.

Students are advised to make careful notes. All questions concerning lectures and text assignments are welcome. It is important for students to gain a reasonable geographical sense of places under discussion. Also, it is crucial that each student develop a chronology of events that will serve as a scaffold upon which to build arguments and interpretations of data.

Tasks:

No grading curve will be used in this course. All individual assignments, exams, and essays are based upon 100 points. Students must accomplish course tasks. There will be no midterm but there will be a final exam. The final exam will consist of essay questions. The final exam will be 20% of the final grade. The final exam will be will comprehensive. Students must take the final exam at BCC on a day(s) to be announced or arrange a local proctor. If students live at a distance a local proctor will be required. A proctor must be an educational professional. Students must produce photo ID in order to take the final. Students who require a proctor for the final exam must find an individual who can proctor the exam and submit the required paper work by May14th. It is the student's responsible to arrange a local proctor if the student is unable to attend the final at Bellevue College. If students require a local proctor please begin searching for a proctor at the beginning of the quarter. Additionally, there will be a weekly discussion normally, but not inevitably, launched on a Friday and running through the following Thursday. Full instructions are posted on the homepage. The two lowest discussion scores will be discarded, the remaining averaged, and that score will represent 20% of the course grade. Full instructions concerning what is expected of students and how discussions are graded are posted on the homepages and assignment calendar. Each student will write three papers 3 to 4 pages in length, typed, double-spaced, and using a ten, eleven or twelve font. The papers will be written in the standard format using the conventions adopted by historians. Reading assignments from A Pocket Guide to Writing in History will be posted to help in the writing of the

papers. The first paper will concern the Communist Manifesto by Karl Marx. The second writing assignment will be based on *Imagined Communities*. The third writing assignment will deal with *Unmodern Men in the Modern World*. Writing guides for the papers will be posted on the course homepage. The papers will be worth 20% each towards the final grade. A writing guide for each writing assignment will be posted on the course homepage. Additional readings will be posted on the course homepage and information concerning the posting of documents will be announced via email and posting on the assignment calendar. Textbook reading assignments will be posted each week on the assignment calendar. There will be no assigning of extra credit work for the course. Any form of plagiarism will not be tolerated and will result in a failing grade for the assignment.

Late Work:

Late assignments will be accepted but with a reduction in points. For each day the assignment is late 5 points will be removed from the score. It is important to complete assignments on the assigned due dates.

Reading Assignments and Deadlines:

All reading assignments for term papers and other deadlines are found on the calendar on a week-by-week basis. Students are responsible for monitoring the calendar daily. **Please check emails daily.**

Cheating, Stealing and Plagiarizing*

Cheating, stealing and plagiarizing (using the ideas or words of another as one's own without crediting the source) and inappropriate/disruptive classroom behavior are violations of the Student Code of Conduct at Bellevue Community College. Examples of unacceptable behavior include, but are not limited to: talking out of turn, arriving late or leaving early without a valid reason, allowing cell phones/pagers to ring, and inappropriate behavior toward the instructor or classmates. The instructor can refer any violation of the Student Code of Conduct to the Dean of Student Services for possible probation or suspension from Bellevue Community College. Specific student rights, responsibilities and appeal procedures are listed in the Student Code of Conduct, available in the office of the Dean of Student Services.

<u>Incomplete</u>

If a student fails to complete all the required work for a course, an instructor may assign the grade of Incomplete ("I"). The student must complete the coursework by the end of the next quarter, or receive the assigned letter grade (usually an "F").

F Grade

Students who fail a course will receive a letter grade of "F."

Final Examination Schedule

The Social Science Division will adhere to the final examination schedule as stated in the BCC Schedule. Final examinations will be held at the end of each quarter at fixed times. Instructors will not give examinations in advance of the regular schedule. A student who is absent from any examination held at any time during the quarter may forfeit the right to make up the examination. If, for illness or some other circumstance beyond the student's control, the student is unable to be present at any scheduled examination and has contacted the instructor on a timely basis, the student may be permitted to take such examination at a time designated by the instructor.

Withdrawal From Class

College policy states that students must formally withdraw from a class by the end of the seventh week of the quarter (Registration Office, B125). If a student has not withdrawn by that date, an appropriate letter grade will be assigned for the course.

Hardship Withdrawal

Instructors may assign the grade of "HW" (hardship withdrawal) at their discretion in the event that a student cannot complete the coursework due to extreme and exceptional circumstances. Students may also contact the Enrollment Services office BEFORE grades are assigned in cases of hardship.

Students Who Require Disability Accommodations:

Return of Papers and Tests

Paper and/or Scantron score sheet returns will be arranged in the following ways ONLY: by mail, if student supplies the instructor with stamped, self-addressed envelope (with appropriate postage); or by the instructor designating a time and place whereby the student may retrieve his/her papers. Unclaimed papers and/or Scantron score sheets must be kept by the instructor for a minimum of sixty (60) instructional days following the end of the quarter.
