# Fall 2017 Syllabus

### **About The Course**

To provide an overview of law in the business environment, law basics and to develop an appreciation of the language and concepts that mandate the law. The course will focus on the regulatory framework within which most business transactions are handled. This will include the cases and laws, which govern the creation of most contracts and the resolution of disputes when contracts are breached as well as other elemental legal concepts and theories; plus dialogues about applicable current events. We will review cases in addition to the textbook (*The Legal Environment of Business*, ISBN-13 #978-0-538-45399-8 [8<sup>th</sup> Edition by Cross & Miller]).

## The Course Objective

Lecture, class discussion, Q&A, fact pattern scenarios, and group activities will be employed. You are responsible for all the topics, which are covered in class, as well as, reading and other assignments. Critical thinking will be required in order to perform well in class. Study guides and rubrics will be distributed or otherwise posted on Canvas when appropriate and in consideration of the course calendar.

#### **Attendance**

I will not require mandatory attendance but you will get the most out of this course by attending class, engaging with your peers, and asking questions. Remember no question is a bad question and there are no wrong answers. This will be a course for you to think, participate and contribute to the overall experience of the class. That said, I will take attendance for my own records.

### **Court Visit**

You will submit an informal paper describing your visit to a series of court proceedings. The instructor will distribute and discuss the guidelines on Canvas (and in the classroom) as the course calendar demands.

#### **Exams**

There are two exams: 1) a mid-term exam (50 points) and 2) a final exam (50 points). The mid-term exam consists of 1) multiple-choice portion and an essay portion with point distribution for each portion being roughly equal. The final exam will consist of 1) short answer questions and 2) two longer essay questions. We will have a study guide and a **possible** practice exam several days before the exams.

## Make-Up Exams:

An exception may be made for documented emergencies, you must contact me as soon as possible so that alternative arrangements can be made to take the test. Remember make-up tests are at my discretion and will only be given with documentation substantiating an emergency.

## **Research Project**

You will be required to research a law that relates to the legal implications related to the many topics covered in the chapters listed above for the quarter. For example, product liability, employment discrimination, international law, etc. You may also research any aspect of internal law i.e. human rights issues; intellectual property issues, etc. Once you select one of the subtopic research areas above begin conducting research about that topic. In doing research you can analyze a case or discuss a business law related to the topics listed above. In order to complete this paper you may have to conduct research in a law library, a court or an internet related legal research site. Your references must also appear in the body of the paper where they are appropriate, whether you are quoting directly or indirectly from the source. Therefore, almost all of your paper should be referenced or footnoted. **And complete the LMC Tutorial.** 

For your research, if you use a regular printed document, be sure to include the title, the

author, the pages, the date and the publisher in your reference. Equally, if you are using the internet, be sure the complete internet address is given on your reference page. I will check the internet references, and if I cannot pull them up on my computer to see where your work came from, the reference will not count, and points will be deducted from your paper. If no references appear in your paper, it will be considered as plagiarized and a "0" will be assigned to your paper. Your grade will be based not only on the content of the analysis but also on the writing itself. Diction, style, grammar, spelling and organization are key elements in this assignment. Write simply and clearly. Prepare a cover page.

For this on-site course, no electronic submission of any kind will be accepted. The only acceptable submission method is in paper copy.

I will not grade partial assignments. I will grade only what you submit in its entirety, i.e., the assignment must be complete at the time of submission. You may not submit it in separate pieces. Without prior announcement or notice, any written assignment may be reviewed via Vericite, an anti-plagiarism application; and academic honesty guidelines may come into play at the instructor's sole discretion. Additionally, specific guidelines concerning assignment submissions may be distributed.

## **ACADEMIC DISHONESTY**

### Penalties

Penalty for first violation: 0 on the assignment without possibility of makeup on that assignment. Depending on the severity of the act of the academic dishonesty, additional course and/or College policies pertaining to academic dishonesty may also take place.

In addition, at the instructor's discretion and whether or not it is a first offense, the instructor may refer the incident to appropriate channels and/or take additional steps, which may result in one or more of the following: 1) suspension 2) expulsion 3) an academic "hold" on your record, preventing you from enrolling in future terms 5) failing grade and/or 6) permanent notation on the student's academic transcripts. There may be additional penalties on a case-by-case basis. Do not risk your academic and professional career by cheating.

## Incomplete, hardship withdrawals, medical withdrawals

There is no eligibility for a grade of Incomplete unless you have finished at least 90% of all course work up to the time that you make the request. The request must be in writing and have your name, course name/number, and a detailed explanation concerning why you will not be able to finish the remaining work. You must make the request no later than Friday of **Week 9**. The instructor retains sole discretion, however, and will grant requests only on a case-by-case basis and with appropriate documentation.

There must be a legitimate "emergency" before the instructor may, at her/his sole discretion, agrees to grant a request for an Incomplete. However, there must be ample, written, documented proof of the emergency. You must attach the documentation to your written request for the Incomplete (see the section above about acceptable

documentation for makeup requests). All supporting documentation must explicitly identify the date(s) of the "emergency"; if there are no dates and/or the date(s) do not match the date(s) of the "emergency," no exception may be granted.

Hardship and Medical Withdrawals are granted only in exceptional circumstances.
