#### **Course Outcomes**

This course is a survey of the history of the U.S. during the twentieth century. Topics include reform movements, the world wars, the Cold War, Civil Rights activism, feminism, and economic, social and political developments. May be used as social science or humanities credit, not both, at BC.

#### How Outcomes Will Be Met

Course outcomes will be met through the following assessments: initial 'Getting Started' orientation assignment (25 points); 5 group discussions (75 points each; total = 375 points); five (5) tests (120 points each; total = 600 points. Grand total class points: 1000.

### Books and Materials Required

In order to keep costs of books and materials to a minimum for my students, I have eschewed traditional textbooks and have selected the following as germane to this class. It is easily obtainable through Amazon or other online book retailers as well as through local booksellers using the ISBN provided. Buying used paperback or the Kindle version will lower the cost considerably. If you have a Kindle device or app, I highly recommend the Kindle version.
