Course Catalog Description

Are sports an avenue for personal empowerment or a path to exploitation? What do sports mean in American society? Study the ways in which sports are embedded in social systems such as the economy, government, and education. Themes include race, class and gender issues, crime and violence in sport, and the economic impact of sport.

After completing this class, students should be able to:

- Explain the role of sport as it relates to the socialization of children and young adults.
- Critically discuss the impacts of sport as it relates to social justice.
- Analyze the intersections of race, class, and gender issues within the context of sport.
- Describe the interconnectedness of sports and societal institutions.

Course Content

Sociologists study a broad range of topics--some of which includes provocative content and adult themes. While every attempt will be made to keep things PG-13, please know that there will be times where R-rated content (language, images, etc.) is necessary to examine course topics within an academic context. Students will not be penalized for excusing themselves from content they find objectionable or difficult to watch, see, discuss or listen to. That being said, students who excuse themselves are responsible for any course material they miss as a result of choosing not to participate. Public Safety and Emergencies
