## **Course Information**

This course serves to introduce students to basic concepts, theories, principles and an historical overview of the criminal process as they relate to the formal and informal adjudication of violent, serious, and chronic juvenile offenders. Prerequisite: CJ& 101 recommended.

### **Course Outcomes**

#### Upon successful completion of the course, students should be able to:

- Distinguish the important differences between the adult and juvenile justice systems.
- Identify the nine Supreme Court cases which have shaped critical issues in the Juvenile Justice System.
- Identify important milestones in the development of the Juvenile Justice System.
- Identify the basic procedures associated with the adjudication of Juvenile court cases.
- Recognize and understand the problems and issues associated measuring Juvenile Crime and Victimization.
- Identify the important aspects of the Diversion and Intake process of Juvenile Justice.
- Identify and discuss the goals and processes of Juvenile Probation and Parole.

### **How Outcomes Will be Met**

Course outcomes will be met via a variety of academic delivery strategies to include participation in online discussion forums, writing assignments, timed quizzes, and individual research.

## **Instructor's Expectations**

Since this class does not meet face to face on campus you are expected to attend the online classroom for AT LEAST one hour five times a week. ## **Rhythm of this Course**

Please read this section very carefully. If you cannot adjust your schedule to the rhythm of the class, you will have difficulty succeeding in this course. Deadlines are firm and the late penalty for this course is strictly enforced regardless of the reason for the late submission in order to ensure fairness for all students. Note, quizzes and discussion forums must be completed during the current academic week only. There are no make-ups on discussion forums or quizzes if you miss them during the current academic week. For assignments, the late penalty is -10% per day. The online class environment has a very different rhythm as compared to the traditional live, on-campus course and each online course is different from other online courses. In this class,

the first day of the online "week" begins on Monday mornings at 12:01am and runs through Sunday night at 11:59pm. All work must be submitted by the 11:59pm deadline in order to avoid the late penalty. There are six major components to this course: 1) Reading the assigned textbook, 2) Viewing all lecture material (PowerPoint slides which are not narrated), 3) Discussion Forums, 4) Assignments, 5) Quizzes, and finally, 6) A comprehensive Final Exam. Each of the aforementioned items are discussed in further detail below.

- 1) Reading the assigned textbook: It will extremely difficult to pass this course without reading the assigned textbook. It is your responsibility to purchase the required textbook for this class. It is up to your discretion to decide the best time to complete each of the assigned weekly readings however they should be completed prior to other assignments due during the same academic week.
- **2) Reviewing the PowerPoint Lectures:** For each major section of the course, there are accompanying PowerPoint slides that you can download and/or print. Additional information and resources are contained in these lectures, which are similar to those given in the oncampus version of this course. These slides are not narrated so that you can proceed at your own pace.
- 3) Discussions: There are ten (10) total discussions in this course, including your initial introduction discussion. First, you must do an initial post (your analysis/research and scientific consideration about the discussion topic) before you post replies to your peers. Your initial research post should be submitted no later than Thursday of each academic week by 11:59pm PST. Second, please be sure to read and evaluate the discussion forum contributions of your peers. Third, each student will be required to make a minimum of two (2) replies in response to other students' posts by the end of the on-line week which is Sunday at 11:59pm PST. Fourth, please submit your work over a minimum of three (3) days during the academic week. Ideally, replies should be submitted after your initial post, and later in the week. Note: Discussion forums are semi-synchronous therefore any discussion forum work submitted after the official conclusion of the academic week (11:59pm PST on Sundays) will not earn credit.
- **4) Assignments:** There are a total of four (4) assignments in this course. Specific directions for the assignments will be provided within the modules. Average length submission is between two to four pages long however just remember that the more substantive and detailed all work, the more credit it will receive. Assignments may be submitted late with a late penalty of -10% per day late assessed.
- **5) Quizzes:** There are a total of four (4) quizzes in this course. Each quiz opens on a Saturday morning at 12:01 AM and closes on a Sunday night at 11:59 PM. The quizzes are comprised of multiple choice and short answer questions. 50 minutes is provided to complete each quiz, the same amount of time for on campus quizzes. No late quizzes are accepted for any reason. All quizzes must be completed during the current academic week only in order to earn credit. In order to submit the quiz on time, it needs to be started at least 50 minutes before the due date/time.

**6) Final Comprehensive Exam:** The final exam is comprehensive and covers all course materials. It will consist of multiple choice questions. It will be due no later than the first official day of final exams (03/20/18) by 11:59 pm. Ninety minutes is allotted to complete the final exam. No late final exams are accepted for any reason so please plan accordingly.
