#### **Course Description**

Surveys the history of American humor. Topics may include the Down East, Old Southwest, and Literary Comedian genres of the 19th century and the Purple Cow and Columnists humorists of the 20th century. Students may also analyze contemporary forms such as cartoons and stand-up comedy.

#### **Course Goals**

### After completing this class, students should be able to:

- Demonstrate an understanding of their own previously-held perspectives on the theme and explain how those perspectives may have changed.
- Demonstrate an understanding of trends in American thought and attitude regarding the theme.
- Discuss, orally or in writing, the theme showing the interrelation of historical events, literary works and social change s.
- Demonstrate the ability to synthesize information from various sources/media and communicate that insight effectively.

## **Course Requirements**

## **Activities:**

Every Monday through Thursday, there will be online-class readings and videos. These activities are not graded, but there is an expectation they are read and/or watched.

## Weekly Reviews:

Every week, there will be a one page essay due at 11:59 PM in Saturday. Your essay must be one full page, double spaced, and Times New Roman font. It must use the three paragraph format (One introducing the topic, another explaining the connection, and the final concluding the topic). When you bring in examples, make sure to cite them properly and include a works cited list. They will be worth 30 points each. (9 total).

## Quizzes:

There will quizzes each, for a total of 395 points. All answers can be found in the readings (open textbook/notes) and the quizzes not timed. (9 total).

## **Essays/Joke Construction:**

This class requires you to write a joke and a one page essay, which requires you to first analyze the idea of the comedian as the social assassin. Then you will write a one page analysis of a classmate's joke. 50 points and 50 points, for a total of 100 points. (2 total).

All papers and other assignments are due at the dates and times specified on Canvas. No late work will be accepted.

## **Plagiarism:**

Plagiarism, or academic dishonesty, is the act of using another writer's words or ideas as your own. Plagiarism "may take many forms, including, but not limited to, using a paper written by someone else, using printed sources word-for-word without proper documentation, and paraphrasing or summarizing the ideas of others without acknowledging the source. Plagiarism can also occur when non-written ideas are taken without documentation--using someone else's design or performance idea, for example. In short, plagiarism is passing off someone else's ideas, words, or images as your own; it amounts to intellectual theft--whether or not it was your intention to steal." Plagiarismin this course may result in a paper's failing grade, or further disciplinary action from the Dean of Student Success. Consecutive acts of plagiarism may result in a failing grade for the class.

## **Values Conflicts**

Essential to a liberal arts education is an open-minded tolerance for ideas and modes of expression that might conflict with one's personal values. By being exposed to such ideas or expressions, students are not expected to endorse or adopt them but rather to understand that they are part of the free flow of information upon which higher education depends.

To this end, you may find that class requirements may include engaging certain materials, such as books, films, and art work, which may, in whole or in part, offend you. These materials are equivalent to required texts and are eessential to the course content. If you decline to engage the required material by not reading, viewing, or performing material you consider offensive, you will still be required to meet class requirements in order to earn credit. This may require responding to the content of the material, and you may not be able to fully participate in required class discussions, exams, or assignments.

### **Classroom Behavior:**

The college's 'Affirmation of Inclusion' is posted in each class room and sets forth the expectation that we will all treat one another with respect and dignity regardless of whether or not we agree philosophically. This expectation is in line with the principle of free speech in a free society: we have the right to express unpopular ideas as long as we don't show disrespect for reasonable people who might believe otherwise. In an on-line course, you will be expressing ideas through the medium of the course site rather than face to face in the classroom. In that case, these expectations refer to the courtesy with which you communicate with one another through e-mails and e-discussions.

Part of this respect involves professional behavior toward the instructor, colleagues, and the class itself. Disruptive behavior is disrespectful behavior. The Division honors the right of its faculty to define "disruptive behavior," which often involves such things as arriving late, leaving early, leaving class and then returning, talking while others are trying to hear the instructor or their group members, doing other homework in class, wearing earphones in class, bringing activated beepers, alarm watches, or cellular phones into class, inappropriate comments or gestures, etc. In on-line courses, "flaming' anyone in the class is also considered disruptive behavior. Such behavior interrupts the educational process. When you are in doubt about any behavior, consult your instructor during office hours: we recognize the judgment of the instructor as the final authority in these matters.

When disruptive behavior occurs, instructors will speak to or e-mail the students concerned. Those students are then responsible for ending the disruptions at once. Failure to do so may result in removal of the students from class."
