### Course Description

Welcome to the Psychology 100 class! The field of psychology is defined as a “scientific study of behavior and mental processes”, and you will learn that psychologists study a remarkably wide range of topics. Examples of topics we will cover include learning and memory, sleep, psychoactive drugs, lifespan development, social psychology, and psychological disorders. We will also talk about the brain, and about how psychologists conduct research. The main purpose of the course is to introduce you to the major concepts, theories and research findings in psychology. More specific goals for the course are listed below.

### Course Purpose & Goals

#### COURSE OUTCOMES

1. Describe the purpose, comprehensive scope, and areas of application in the discipline of psychology.
2. Apply and/or critique various research methods used by psychologists in the study of behavior.

3. Recognize, compare and contrast various theoretical perspectives used to explain and guide psychological research and application.
4. Identify historical and present-day contributions of major psychologists.
5. Define key psychological terms, concepts, processes and principles.
6. Apply critical thinking to assumptions, claims, and common sense ideas about behavior.
7. Apply psychological principles and findings to one's own life.

## **STUDENT LEARNING OUTCOMES**

## **Student Exams & Activities (570 points total)**

- 1) **8 Canvas Quizzes (160 points):** There will be 8 quizzes that you will take online. 7 of them are each worth 20 points, and a longer final quiz is worth 40 points. Of the 7 20-point quizzes, your lowest score will be automatically dropped, so that only 6 of the quizzes (120 points) count towards your final grade. The last 40-point quiz cannot be dropped. None of the quizzes is comprehensive; each quiz only covers the material for the given module (one chapter, except the last quiz covers two chapters). The quizzes are available SATURDAY 8 AM – MONDAY NIGHT 11:59 PM after the lectures in class about the quiz topics. See the course schedule and calendar for the deadlines. The last 40-point quiz will be due on the final exam week. The quizzes are timed and can only be taken once. **No make-up quizzes will be given. Since your lowest score will be dropped, if you miss a quiz, the missed quiz will be accepted as your lowest score.**

- 2) **Canvas Assignments and Introduction (140 points + 10 points):** Students evaluate articles and other sources related to assigned topics (e.g. evaluation of toys, psychoactive drugs, etc.), and discuss their findings online in Canvas. **Students are expected to research the topics, write and post summaries and participate in the discussions online (or in class for one assignment) to receive the points.** More information about these assignments will be given in class and is posted in Canvas. Students also post an introduction and respond to two other students' introductions in the introductory module of the Canvas site (for 10 points).
- 3) **Class Assignments/Attendance (200 points):** Attendance in the lectures is required and especially important in this class because we only meet twice a week and have fewer lectures than in a typical class. I will take attendance for credit in most lectures and give you 20 points if you are present. **Students need to collect 10 attendance recordings for the full 200 points.** However, if you get an 11<sup>th</sup> attendance recording, you receive **10 extra credit points**. For some lectures, you will be given questions about the lecture topics that you need to answer BEFORE you attend the class. You need to bring your written answers to the lecture, and we may discuss them during the lecture. For other lectures, there are no pre-assigned activities, but instead attendance will be recorded during the lecture with an in-class assignment. **You need to attend the entire class to receive the points. No points will be given for these assignments/attendance recordings if you are absent or do not attend the entire class.** I will not accept emailed assignments, and attendance cannot be made up for any reason.
- 4) **Lecture quizzes (60 points):** In many lectures (marked in the schedule), there will be a short open-book quiz related to the class material. Each quiz is worth 10 points, and will include about 5 questions (multiple choice, true/false and/or matching; no essay questions). The quizzes occur in the last 5 minutes of the class. They cannot be made up: they are only given to students who are present in the class. Any points collected above 60 for these quizzes count as **extra credit**. **No scantrons are needed for these quizzes.**

In addition, in order to receive points for class assignments, **you need to participate in the class activities**. If you stop attending, you must withdraw yourself from the class to avoid earning a 0.0 in the class.

### **Punctuality and class conduct:**

You should arrive on time for class and stay the entire period. If you do need to leave early, please notify me in advance and sit near the door if possible to avoid disrupting others. **If you arrive late and the class is completing attendance assignments, come talk to me and I will assign you to a group. It's not acceptable to join a group and write your name on the assignment as if you completed the full assignment** (unless you arrive only a few minutes late). **Please keep your cell phones and other electronic devices silent or turned off during class. CELL PHONE USE IS NOT ALLOWED DURING THE LECTURES. This also includes "silent cell phone use"**. You are encouraged to share your views and participate in class discussions in a manner that is respectful of others. You are encouraged to critique the material presented and discussed in class and the readings, but critique should be based on theory and research evidence, not individual experience alone. Side comments directed to other students, use of electronic devices, and activities that are not related to the learning material are disruptive. A student who engages in persistent disruptive behavior will be asked to leave the classroom.

### **My laptop policy:**

During lectures, I only accept the use of laptops FOR NOTE TAKING RELATED TO THE CLASS MATERIAL. Any other use of laptops is not permitted (unless pre-approved by me). This is because laptop use during lectures can distract you and other students. Laptop use is not allowed at all during films we watch in class. If you use a laptop in class, I may request to see your lecture notes from the lecture, and you will need to provide them immediately upon request. If you have an accommodation for laptop use, the DRC will notify me of your accommodation.
