**Course Catalogue Description** In this class we will explore a variety of dance forms from throughout the Afro-Latin Diaspora: Salsa, Afro-Cuban, Brazilian, Bachata and more. This course will meet once a week in the dance studio and once a week in lecture hall. CES 210 can be used to fulfill either a social science or a humanities elective and is taught by Oriana Estrada

## **Content and Pedagogical Approach**

This class will be a hands on, kinesthetic learning experience. You will gain knowledge about the history and culture of Latin America through its rich and diverse music and dance traditions. You do not have to be a seasoned dancer to take this class, it is appropriate for all levels. Most people feel self-conscious about dancing and moving their bodies, especially in front of others. In this class you will be challenged to confront that discomfort and encouraged to do it anyway. Attempting to execute the basic dance patterns is a requirement of this course.

Through Interactive dance lessons, readings, documentaries, video clips, online reflections and in class group discussions you will learn not only how to execute the basic dance moves of selected Latin American dance genres but come to understand the larger historical and social context of each country in which the dance forms evolved.

# **Learning Outcomes:**

After completing this class, students should be able to:

- Identify and describe selected styles of dance from Latin America
- Execute the basic steps of selected regional dances of Latin America
- Understand and discuss the racial and cultural history of Latin America and how this influenced it's music and dance traditions
- Demonstrate greater appreciation, understanding and respect for Latin American Culture
