COURSE FORMAT

This is an online course that does not require us to meet face to face on campus. You are expected to attend the online classroom for AT LEAST one hour, four times per week. To be successful in this class, you will need to be reading the textbook, viewing the materials, videos and any power points, and reviewing guidelines and grading rubrics posted within the weekly Modules and Files Section on the Canvas classroom page. COURSE OVERVIEW

Studies the First, Second, Fourth, Fifth, Sixth, and Eighth Amendments to the U.S. Constitution and their impact on contemporary police practices. Students analyze Supreme Court decisions concerning arrests, searches, seizures, self-incrimination, and post-indictment right to counsel.

COURSE OUTCOMES

After completing this class, students should be able to:

- Explain the history of the U.S. Constitution; the importance of the Constitution and the development and role of the United States Supreme Court.
- Explain and discuss the process of judicial interpretation of the Constitution and the impact of the philosophies of the individual justices on the court's decisions.
- Explain the legal terminology and concepts in the area of Constitutional Law.
- Identify and explain selected individual liberties as established by the Constitution, the Bill of Rights and other amendments.
- Explain and discuss historical decisions handed down by the U.S. Supreme Court and to further discuss contemporary issues facing the U.S. Supreme Court today.

COURSE REQUIREMENTS

Reading: It is imperative that you read the required text as it is assigned, if you do not utilize the textbook it will be difficult to get through this course. Make sure you are prepared with the textbook and are keeping up to date with where we are at in the book throughout the quarter. **Discussion Boards & Responses:** There will be one introduction discussion board (worth 10 points) and nine (9) discussion board posts (worth 20 points each). Discussions board posts need to be thorough and thoughtful, utilizing the materials that were assigned in that week's module. You will need to respond to the discussion board prompt for each week AND respond to two (2)

- Discussion Boards will be due WEEKLY.

Assignment(s): Each assignment/review is worth 30 points, 1-2 pages in length approx., will vary depending on assigned task. Details for each assignment will be provided in advance of the deadline within the assignment in Canvas.

Quizzes: There will be three (3) quizzes this quarter. Quizzes are timed and you will have one opportunity to complete. The first will be a syllabus quiz – this is to encourage review of the syllabus at the beginning of the quarter. This is to ensure that you are aware of what is expected and required. The syllabus quiz will be accessible when you first access the course and I encourage you to have the syllabus handy while you are completing the quiz and it is required to complete before moving forward with any course work. The remaining quizzes will be based on the textbook, power points, and other assigned materials and could consist of multiple choice, true/false, and short answer questions. The remaining quizzes will open on **Friday at 5:00pm PST** and will be due by **Sunday at 11:59pm PST** on the weeks that they are due. Quizzes will only cover the materials outlined within their directions (exams will be cumulative).

- NOTE: Quizzes are open book/open note.
- *NOTE:* The quizzes cannot be unlocked early. In addition, if your quiz is not completed by 11:59pm it will be locked out and you will not have a chance to submit or complete partial quizzes.

Exams: There will be a midterm exam and a final exam. The midterm will cover the chapters that we have covered with the materials through week 6 in the quarter. The final exam will be comprehensive and cover all material covered throughout the quarter.

- The midterm will be worth 50 points.
- The final exam will be worth 100 points.

The final exam will be due Tuesday, 3/17/20 at 11:59pm via Canvas. This will be a timed exam and you will be required to complete the exam on Canvas sometime between Monday, 3/16/20 at 9am and Tuesday, 3/17/20 at 11:59pm.
