# **Course Description:**

Welcome to the Cognitive Psychology 203 online class! Cognitive Psychology is the study of mental processes, including memory, language, perception, attention, and reasoning. The goal of cognitive psychology is to explore how the mind operates. This can be accomplished with various behavioral measures, by observing the brain with neuroimaging, and by studying people with brain damage.

## Outcomes:

Students successfully participating in this course will:

- 1. Demonstrate a basic understanding of the history of cognitive psychology and its influence on other fields of psychology.
- 2. Develop critical thinking skills, an understanding of the methods and principles of cognitive psychology research, and an understanding of cross-cultural influences on cognitive processes.
- 3. Develop communication skills using oral and written materials to discuss topics related to human cognition.
- 4. Express a basic understanding of the neural bases of mental processes, and gain knowledge about the brain research methods utilized in cognitive psychology.
- 5. Distinguish the processes of sensation and perception, object recognition, and attention.
- 6. Examine the theories and physiological processes of memory encoding, storage and retrieval. Recognize the practical applications of cognitive psychology of memory, such as eyewitness testimony and the concept of false memories.
- 7. Indicate knowledge about the theories related to conceptual processing and language, including the neural basis of language, the structure and principles of human language, and language development.
- 8. Extend knowledge about the principles and applications regarding problem solving and reasoning.

#### STUDENT LEARNING OUTCOMES

In terms of general education outcomes, students will be able to: Use cognitive and creative skills:

- a) Analyzing (identifying and evaluating problems)
- b) Synthesizing (interpreting situations, drawing conclusions, and making connections) Improve communication skills:
  - a) Doing research (gathering and documenting information)
  - b) Delivering one or more written, oral and/or visual presentation with formal documentation

# Exams & Activities (280 points total)

- 1) **Exams (90 points):** There will be 3 exams, and each exam is worth 30 points. The exams have multiple-choice, true/false, matching and some short-answer questions. One of the shortanswer questions is about a Zaps lab assignment, and some questions can be related to the Critical Questions essays provided in Canvas. Each exam covers the chapters assigned for the designated module(s). Each exam also has an extra credit question that is optional. The exams are taken online in Canvas. Once you start the exam, you must finish it, and you have 120 minutes to complete the exam. Each exam is open for 4 days, and you can take the exam any time during this open period. Please note that if you start the exam less than 120 minutes from the deadline of 11:59 pm on the last exam day, the exam still automatically closes at 11:59 pm. No late exams are generally given, but please contact me for exceptional circumstances such as serious illness/death in the family. If possible, do not take the exams with a cell phone. A student who has a legitimate medical situation or other emergency needs to communicate with me promptly and contact me as early as possible before the exam deadline. Please note that the exam answers will be revealed after the deadline. After they are revealed, no late exams are possible.
- 2) Podcast assignment and Cognitive psychology in the world (60 points): You will summarize and evaluate a "Hidden Brain" podcast episode, read other students' posts and comment on two of them. The comments should address the content of the students' posts, showing that you read them. You will also pick a world event and analyze the cognitive psychology concepts related to it, and comment on other students' posts. See the more detailed instructions in Canvas.
- Discussions (120 points): We will have 5 discussions in Canvas, one for each module. In each discussion, you need to post 4 TIMES: 2 times in response to my questions, and 2 times in response to other students' posts. Your 2 posts in response to my questions are worth a maximum of 10 POINTS EACH, and your 2 responses to other students are worth a maximum of 5 POINTS each. Thus, you can collect up to 30 points per discussion (30 points x 5 discussions = 150 points total). However, only 120 points are required for full points. Any points collected above 120 are extra credit (or each student can miss one discussion without losing points). It is very important that you read the detailed instructions about how to post in the file labeled "Course structure" in the introductory module. When you cite sources in your posts (which is required for many posts), you need to use APA format in-text citations and an APA format reference list.
- 4) <u>Introduction (10 points):</u> You need to post an introduction and respond to two other students' introductions in the introductory module. See the course schedule for the deadlines.

Students who fail a course will receive a letter grade of "F."
