## **Course description:**

Psyc&100 is a general psychology class. It includes examining different concepts pertaining to human cognition, emotions, behaviors and perceptions. It comprises of studying the empirical facts in a scientific way which are often studied in laboratories and controlled settings. In this class, you will have the prospect to engage in different learning experiences. Most common ways would be lectures, presentations, assignments, videos, research papers, understanding and applying the APA (American Psychological Association) style. At the end of this class, you will be able to understand various ways in which human behavior, cognition and interaction can be evaluated. It will help you develop the ability to critically evaluate assertions about human behaviors and make observations around you.

### **Course outcomes:**


- Describe key concepts, principles, and overarching themes in psychology

#### **Introduction guiz**

In order to know a little bit about you I have created this quiz. Complete this quiz so I get to know you more. All the information you share will be of great assistance for me to help you succeed in this class. There is no time limit on this quiz, and you will be awarded the grade as soon as you complete it.

### Pre and Post Assessment quiz:

Pre and Post assessment quiz contains a scenario based off of which you will be answering 5 multiple-choice questions. You will answer them based on your existing knowledge of psychology; don't look anything up! You will earn full credit for completing the quiz, regardless of the accuracy of your answers. Answers won't be revealed to you after the quiz; instead, you'll learn about the correct answers as we cover course material during the quarter. Pre assessment will be done at the beginning of the quarter and post assessment at the end of the quarter.

#### Syllabus quiz

You should always consult the syllabus first when you have a question about the class. Chances are, an associated policy is outlined here, and I strictly adhere to my policies. To make sure you have read and understood the policies for this course, you will take a syllabus review quiz on Canvas as your first assignment.

#### **Lecture notes**

For each chapter (2-3 lectures/week) you will be **completing one lecture/chapter note guide** that will help you follow through the concepts covered in the lecture and pay attention to the important aspects of the class that may show up on the test/quizzes. **Your lecture/chapter notes are graded, 10 points each**. Grade will be determined by, if the notes are completed, the depth of notes taken, all questions are answered, examples provided wherever necessary. Lecture notes will be **due every Saturday** at **11:59 pm**.

#### **Chapter Quizzes**

You will complete a short **multiple-choice quiz** for each chapter we cover. These quizzes can be found on the "**Quizzes**" page of Canvas website. All chapter quizzes are available to be **retaken 2 times** to obtain a perfect score before the due date with a **25 minutes**' **time limit**. **Quizzes will be due every Sunday night at 11:59pm**.

#### **Reading and Writing Assignments:**

Throughout the quarter you will be completing **8 reading and writing assignments** linked to the chapters that will count towards your final grade. This is intended to help you follow through the concepts covered in classroom. Each **activity/assignment** is worth **10 points** and will help you apply the concepts learnt in class and will be **due every Sunday night at 11:59pm**.

#### **Unit Exams**

Unit 1 & 2 will culminate in **2 exams worth 50 points each**. These exams will consist of **multiple-choice questions**. These exams will be online.

**NOTE:** If you are concerned about your ability to understand exam questions due to a language barrier, you may use a translation dictionary or an electronic translator **without internet access**. If this applies to you, speak with me immediately. **I must approve your device before you may use it on an exam.** 

### **Rules and Classroom Policies**

### 1. Participation:

Since we are fully online now, participation will be in the form of completing your course objectives on time, posting in the discussion posts, logging onto canvas every day, watching the lectures/going over the topics from textbook and completing lecture/chapter notes, doing chapter quizzes on time will be accounted for as participation. This is a relatively easy part of your grade to score full points on. All you have to do is fulfill the expectations of this course and you will be awarded full credit. Reasons you may lose points are, constant late submissions, missing assignments, not watching lecture videos/ doing textbook reading, not completing the lecture notes thoroughly.

### 2. Late policy:

It is important that you meet the deadlines for all assignments. I ensure that you get enough time to complete the assignments. Late submissions will cause you to lose points. Assignments turned in 24 hours late will face a 20% penalty. Assignments submitted later than 48 hours will not be accepted. In case of emergencies, late submissions may be allowed only if the reason is discussed with me and a legitimate document is presented when necessary.

If you know that a week is going to be stressful for you, contact me before hand to ask for extensions. I appreciate thoughtful requests that are made beforehand as a result of careful planning. In some cases, I will be open to extending the due dates.

#### 3. Contacting me:

The best way to get in touch with me is via Canvas message or Bellevue College email (<u>madhura.sohani@bellevuecollege.edu</u>). I check my email regularly and you can expect a reply within 24 hours on weekdays. It may take me longer than 24 hours to reply on the weekends. It is important that you ask brief questions with clarifications when necessary. Anything that needs detailed explanations should be talked about in person during or after the class or my office hours. If I do not reply in time, please try and send me the email again.

#### 4. Make Up Exams:

Make up unit exams will only be allowed if legal or medical documentation to explain your absence is presented. Exams may be taken early with at least one week's notice and with written documentation for the upcoming absence.

### **Tips for Success:**

- Read all material and watch videos on the topics that are unclear to you.
- Video lectures/PowerPoint slides will be available online.
- Take advantage of office hours or email if you have questions about the material.
- Make flash cards of key terms, be able to name terms when given a description, and vice versa.
- Form a study group with other students in the class (but make sure to complete assignments independently).
- Go to Psychology Tutoring in the Academic Success Center (D204).

### **Important Notes About Technology Use:**

I will be posting class material (e.g., syllabus, PowerPoints, announcements, readings, assignments, and links to articles) regularly on the Canvas course website. **Plan to check the Canvas website regularly.** If you don't have a home computer with Internet access, an open computer lab is available in N250. You will have plenty of time to complete assignments. Excuses such as "my internet wasn't working," "I couldn't make it to the computer lab this morning," or "I thought I posted on the discussion board" will not be accepted.

You are required to create a BC student network account <a href="https://example.com/here.com/here">here</a>. The student network account may be created any time after you receive your student identification number (SID) and personal identification number (PIN). For students enrolled in credit classes, the SID and PIN are issued after you apply for admissions. For students enrolled in classes through BC Continuing Education, the SID and PIN are established after you register for a class. **Incomplete vs. F:** If a student fails to complete all the required work for a course, an instructor may assign the grade of Incomplete ("I"). It is the student's responsibility for maintaining contact and adhering to the agreed-upon actions. Canvas class sites, and material may not be directly accessible after the end of the quarter so it is important to decide before the quarter ends. The student must complete the coursework by the end of the next quarter, or receive the assigned letter grade (usually an "F"). There is a standard form that instructors have access to in their instructor's grade briefcase.

**F Grade**: Students who do not withdraw by the deadline and fail a course will receive a letter grade of "F."

**Final Examination Schedule:** Final examinations may involve proctored on-campus arranged exams or may be administrated completely online at the discretion of the instructor and in keeping with the stated policies provided in the course syllabus. Please refer to the syllabus at the start of the quarter for additional details and contact the instructor directly for any clarifications. A student who is not in compliance with the scheduled format may forfeit the right to make up the examination. If, for illness or some other circumstance beyond the student's control, the student is unable to follow any scheduled examination and has contacted the instructor on a timely basis, the student may be permitted to take such examination at a time designated by the instructor.

**Withdrawal from Class**: Academic Year: College policy states that students must formally withdraw from a class by the end of the seventh week of the quarter (Registration Office, B125). If a student has not withdrawn by that date, an appropriate letter grade will be assigned for the course. Check the <u>enrollment calendar</u> for additional details. Hardship Withdrawal (HW): Hardship Withdrawal indicates a withdrawal request made because of extenuating circumstances after the official withdrawal period is over.
